Level One (1) Storm Water Pollution Prevention Plan Requirements (SWPPP)

What Is A Level One SWPPP?

A Basic Storm Water Pollution Prevention Plan that identifies all land-disturbing activity on a parcel including but not limited to existing site conditions, sediment & erosion control BMPs, stabilization measures and other design criteria as it applies.

When Does It Apply?

A SWPPP can be submitted when land disturbance is proposed that is not subject to any Zoning and/or Landscaping requirements. The Level One SWPPP is intended to permit minimal disturbance (less than (1) acre) on lots and small parcels. There are some exceptions and a determination is made on a case-by-case basis.

Review Process

Step 1: Upload project into Trakit9 (Link) SELECT: ["Level I SWPPP"]


> SWPPP Reviews are 'not' part of the 18-review process. SWPPPs are reviewed within seven (7) days of completed submittal.

Step 2: Project is reviewed by the Department (7) Business days within and an email notification will be sent with status.

- ➤ If <u>Approved</u>, the email notification will state this and the applicant can log in to their account to retrieve the approval notice and stamped (digital) plans.
- > If <u>Disapproved</u>, the email notification will state this and the applicant can log in to their account to retrieve reasons for disapproval.

Step 3: Retrieve status and follow instructions of the status email.
