<u>Welcome and Call to Order</u>: Mullis called the meeting to order and Laney gave the invocation at 6:01 pm.

Approve Agenda and Minutes: Laney made a motion to approve the agenda, which was seconded by T. McSwain. The motion was put to a vote, and it passed unanimously. Additionally, T. McSwain made a motion to approve the minutes as presented, which was seconded by Burts. The motion was brought to a vote, and it also passed unanimously.

Special Presentation: Dr. Kirby Player, Professor of Agricultural Education at Clemson University, provided an overview of the SC Commissioner's School for Agriculture. He highlighted that 2023 marks the 20th year of the program's operation. Since 2004, the program has hosted 679 participants, with 92% of them from South Carolina. They have drawn students from 45 counties within South Carolina and an additional 16 states, making it a multi-state initiative. RSWCD and the SC Association of Conservation Districts are sponsors of the program.

<u>Richland County Conservation Commission (RCCC)</u>: Epps reported they are re-evaluating the strategic plan and also preparing a new annual plan to present to the County Council in March of 2024. They are still monitoring easements and continuing to work on a land deal.
